

**A short synopsis of the book entitled “The Common Man Guide for the Perplexed, and the Parallax Point of View of the World, the Most Common Delusions Affecting the Mankind”**

The existence of the critical writings of Jan Hus of Moravia or Bohemia, and the writings of Martin Luther of Germany, in the middle ages of Europe, and their respective thought processes attacking the integrity of the almighty, totally corrupted, with greed and graft, and inequitable, Catholic Church of the middle ages in Europe is well known. Those writings point out the degeneration, total corruption, greed and the lust for power of the Catholic Church in Europe at those times, as contradictory to the so-called “scriptures,” which they referred to as the “gospels,” which are also commonly known as the “New Testament.” Both of those writers, assumed, implicitly, that the “gospels” contain the entire “truth” that a man needs to know, and they are even “holy,” as they clearly have become over time after countless, and mindless repetitions. Both of those authors point out the organized human perversions of those “scriptures,” the “gospels,” against the great masses of men and against the universal “salvation,” which according to them, were being done by the Catholic Church.

As a result of that, a major spilt has occurred in the Christendom, namely into the Catholics and the Protestants, and it was being followed by mass persecutions, wars, murders, and executions, paradoxically all in the name of their perceived “common” god, whom they called the “Christ the Son of God.” Henceforth, there was an unprecedented rise of the usurpers in this world, which unleashed unspeakable wars, state and theologically supported genocide, murders, and the destruction of countless civilizations and cultures, all in the name of that imaginary god, or gods, being tacitly tolerated by those respective mind-altering organizations, namely the Church and the Protestant equivalents, and their various kings, queens, self-declared rulers and other usurpers.

By contrast, this book is about opening your mind, the mind of the reader, in order to understand the reality as it is, and not as painted to you, falsely, by those subversive organizations.

This book assumes, and it demonstrates, that the various gods, especially those affecting the so-called Western Civilizations, arose in response to certain times, events, and historic upheavals in the history of a small tribe of men, also known as the children of Israel, commonly referred to as the Jews. That history was closely intertwined with the ancient empires of Egypt, Babylon, Persia and the Roman Empire.

This book postulates that those ancient writings are all man-made, in response to those historic events and perhaps the great trauma, or series of traumatic events that occurred in the past.

This book questions the continued relevancy of those ancient doctrines, which over time have lost their meaning, or any value to the mankind, as explained in the book. The problem is that those past theories, together with their respective gods are based on the Chaldean deceptions, deliberate distortions of history, fabrications of facts,

delusions, self-delusions, deceptions, and are pregnant with interest, bias, prejudice and the respective advocacy of the primacy of their respective false gods. In no way, Jan Hus or Martin Luther realized of those obvious problems, because it would have been high treason, heresy and blasphemy in their times.

This is a critical review of various theological doctrines and the various, quite antagonistic gods that the mankind worshiped and invented during the past several thousand of years. Commencing from the ancient creator gods, as set forth in the first chapter of the book of Genesis, through the second god of the second chapter of the book of Genesis, who creates the man again, and he immediately subordinates a woman to the man, as his presumptive slave.

Each chapter of this book can be read and understood separately from each other. And, each chapter is separately numbered.

This book also discusses the ideals and the principles of the American Revolution, which was a period of a brief and very creative mental awakening of the humanity. In that, the principles advocated in the American Revolution, more particularly in the Declaration of Independence, effectively assert a “quasi-theology,” because they declare that all men are created equal. That is precisely the implied assertion of the first god of the first chapter of the book of Genesis. The principles of the American Revolution are a “quasi-theology,” because there is no god declared, there is no supervising tyrant over the people, and there are no priests created, or needed. In fact, all the tyrants and the usurpers of this world are rejected, especially the king of England.

Those principles of the American Revolution have been perverted, abrogated and denied, particularly because the country, and the Western Civilization, have become Zionized and Neo-Zionized, taken over by the doctrines which are contradictory and antagonistic to those principles.

The term, “Zionized,” means that some elements of the public in general, are so arrogant, that whatever they say or write is absolutely “true,” that they consider themselves to be the superior “prophets,” totally “righteous,” and everything else is, therefore, false. This disease of “Zionism” is affecting the Quasi-Jews, whom I call the followers of the old laws of Moses, which cannot be fulfilled, because their old god, the Lord God is dead, as he lies dead in Jerusalem, as “killed,” by the Romans in the year of 70 AD. The Neo-Zionists, who are also commonly referred to as the Christians, are also completely “Zionized,” because their “gospel” “truths,” and consequently their advertised “kingdom of heaven,” although being an absolute fiction and a delusion, or the Chaldean deception, also advocate that their “teachings” are absolutely “true,” and superior, hence all the other “teachings” are false. In addition, their god, or one of them, the “Christ the Son of God,” who is undoubtedly dead, as he was “killed” already twice. Besides being a total literary fiction, he was killed by the Romans after being duly convicted of a heresy and blasphemy, and he also died at the battle of Verdun, in France, during the World War I, as argued in this book.

The term “Neo-Zionist” really means the people who call themselves the “Christians.” It is very much related to the original classical Zionism, as expounded in the Zionist “constitution,” which is commonly referred to as the “Old Testament.” As explained in this book, because of the presumed death of the only god of the children of Israel as a

result of the destruction of the Persian temple in Jerusalem, that Lord God, the proclaimed king of the Jews, and their only “redeemer” and their only “savior” was considered dead by their deluded, traumatized, and possibly insane brethren, the “gospel” writers. Those “gospel” writers created entirely new set of the gospel gods. Initially, those gospels were strictly addressed to the children of Israel only, to the Jews, but because the children of Israel were forcibly evicted from the land of Palestina after the Jerusalem calamity in the year of 70 AD, that disease and the mental stupor of the “gospels” spread to the general population of the entire Roman Empire. In short, the Neo-Zionists, believe that the “gospels” contain the entire “truths,” and that they are only the “truths, which over time became even “holy.” That exact same disease of the mind is contaminating the Quasi-Zionists, who still cling to the “truths” of their fabrications and deliberate Chaldean deceptions contained in the Zionist constitution, the “Old Testament.”
